In the event that Student remains enrolled at College and any installment payment is not paid on the date it is due, then the entire unpaid balance of principle will, at the option of College and without notice or demand, become due and payable. This will include collection and reasonable attorneys fees incurred.

Payment will be deemed late if any installment payment is not paid by the date it is due. In that event, Student will be considered withdrawn from class and be prevented from registering for courses for the next semester until such time as the balance is paid in full. College may take whatever steps it deems necessary for the collection of the balance due. In the event College institutes collection procedures for payment of any unpaid amounts due hereunder, Student shall become liable for payment of any costs of collection and reasonable attorneys fees incurred.

The undersigned, any guarantors, sureties or endorsers, jointly and severally, waive demand for payment, notice or non-payment, notice of protest and protest of this Note, and agree that the liability hereunder shall not be affected by an extension of the time of payment of all, or any part, of the amount owed.
